TERMS AND CONDITIONS

- 1. The information contained in the Information Brochure is only for general guidance and should not be treated as legal document. It could be changed / modified from time to time by Competent Authority of the University.
- 2. Cancellation of Admission: The University reserves its right to cancel the admission of successful Candidate under any of the following circumstances:
 - a) If the fee is not deposited by the stipulated date.
 - b) If the candidate does not join the particular programme by the stipulated date or leaves the course without obtaining permission from the University even though the Fee has been deposited.
 - c) If the candidate fails to furnish the proof of the stipulated minimum qualifications.
 - d) Admission to the M.Phil./Ph.D. programmes will be made on the basis of entrance test conducted by the University and interview by DRC of the concerned faculty. Applicants failing to clear interview in two successive attempts shall be asked to submit application form de novo with fresh processing fee and application fee.
- 3. In case a M.Phil/Ph.D. student admitted to the M.Phil/Ph.D. course of a faculty opts to leave / discontinue the course in between, he will have to pay the complete course fee of M.Phil/Ph.D. course and the fees already paid by him/her will not be refundable.
- 4. The Competent Authority of the University reserves the right to alter or modify the structure of any of the programs to attain the objective of excellence.
- 5. Fee once paid is not refundable in accordance with Section 2 (g) of the Jodhpur National University, Jodhpur Act 2009.
- 6. The University reserves its right to change the existing fee structure.
- 7. The University reserves its right to modify, alter and / or include any other Terms and Conditions that may be deemed necessary in the interest of running the course.
- 8. **Jurisdiction:** Any dispute pertaining to admission, or any matter as a student or alumnus of Jodhpur National University shall be subjected to the jurisdiction of the Jodhpur Courts only.
- 9. Ragging within or outside the University is prohibited. Whoever directly or indirectly commits, participates in, abets or propagates ragging within or outside the University shall be punished, which may extend to fine/expulsion/ imprisonment.

They have to try a fresh next time by paying application form fee and processing fee. The application form fee and processing fee are neither refundable nor adjustable for the next attempt.
